## Unit 9 Assignment

The scientific method emphasizes the use of precision, objectivity, critical thinking, careful observation, practice, repeatability, uncertainty management, and peer review, all of which help support the reliable collection, measurement, and interpretation of clues in order to produce knowledge about a situation.

In 3–5 pages, excluding the title and reference pages, discuss the scientific approach used to identify and collect various types of trace, blood, and/or other biological evidence that has the potential to resolve a criminal investigation.

- 1. Provide a detailed example of clues that can be gleaned from the detailed observation, examination, and analysis of at least two specific types of trace and/or biological evidence.
- 2. What procedures must be followed by the crime scene investigator during the evidence collection process to ensure that accurate and reliable scientific results can be obtained from a forensic analysis of the evidence?
- 3. Include in your paper how a crime scene investigator would defend their research in a court of law.

#### **Directions**

In addition to fulfilling the specifics of the Assignment, a successful paper must also meet the following criteria:

- Include a cover page and references page in 10–12 point font (Arial, Courier, and Times New Roman are acceptable)
- Viewpoint and purpose should be clearly established and sustained
- Assignment should follow the conventions of Standard American English (correct grammar, punctuation, etc.)
- Writing should be well ordered, logical, and unified, as well as original and insightful
- Your work should display superior content, organization, style, and mechanics
- Appropriate citation style should be followed

### You should also make sure to:

- Include a title page with full name, class name, section number, and date
- Include an introductory and concluding paragraph and demonstrate college-level communication through the composition of original materials in Standard American English
- Use examples to support your discussion
- Cite all sources on a separate reference page at the end of your paper and cited within the body of your paper using APA format
