Throughout this course, many of your Assignments will focus on two countries as well as the United States. Pick one country from Group 1 and one country from Group 2. These countries and the United States will establish the basis of your research throughout this course.

For this unit's Assignment, submit a paper that provides a 250 word summary for *each* country (including the United States). Address each of the following as it relates to each country:

- The policing model,
- The judicial structure and the corrections systems,
- The legal tradition (Common, Civil, Islamic, Other), and
- A brief history of the development of the country and how its culture affected the development of its legal system.

Your paper should be in APA format and include a title and reference page. Page length, 1,000 - 1,250 words. Use at least two credible sources beyond the text material to support your positions. You may consult the Library, the internet, and other course material.

In addition to fulfilling the specifics of the Assignment, a successful paper must also meet the following criteria:

- Include a cover page and references page in 10–12 point font (Arial, Courier, and Times New Roman are acceptable)
- Viewpoint and purpose should be clearly established and sustained
- Assignment should follow the conventions of Standard American English (correct grammar, punctuation, etc.)
- Writing should be well ordered, logical, and unified, as well as original and insightful
- Your work should display superior content, organization, style, and mechanics
- Appropriate citation style should be followed

You should also make sure to:

- Include a title page with full name, class name, section number, and date
- Include an introductory and concluding paragraph and demonstrate college-level communication through the composition of original materials in Standard American English
- Use examples to support your discussion
- Cite all sources on a separate reference page at the end of your paper and cited within the body of your paper using APA format
